Historical Sketch:

The Vice President for Academic Affairs was formally established as an executive position of the Medical College of South Carolina at the October 14, 1966 meeting of the Board of Trustees. Prior to the creation of this position the President of the Medical College handled both hospital and academic administrative issues. Since its inception, the institution had grown a great deal and the new position was needed to assist the President in effectively and efficiently running the institution. Through changes to the by-laws, the Board created the position "1st Vice President" which assumed responsibility for all administrative duties pertaining to faculty, students, and academic affairs.

The position was originally designated as the Vice President (Academic Affairs) and Dean of the School of Medicine. Dr. Franklin C. Fetter was hired as Dean of the Medical College in April 1966 and assumed the role of 1st Vice President in October 1966. At the April 14, 1967 Board meeting, a motion passed that separated into two positions the position held by Dr. Fetter: 1st Vice President and Dean, School of Medicine. Dr. Fetter retained the position of Dean of the School of Medicine. Upon stepping down from the 1st Vice President position, the President of the Medical College assumed Dr. Fetter's duties until the appointment of Dr. James W. Colbert, Jr., as the first Vice President for Academic Affairs on February 1,1969.

The Board of Trustees appoints the Vice President for Academic Affairs position with advice from the MUSC President or the appropriate standing committee. The incumbent is administratively responsible to the President for all academic matters. In the absence of the President of the University, s/he acts as the Chief Executive Officer. The Vice President for Academic Affairs and Provost is responsible for the coordination of planning for education and research and formulates plans to implement policy approved by the President. The Deans of each college report to and through this office to the President of the University. Associated duties include responsibilities for overseeing the educational and clinical activities of the MUSC affiliates (those organizations that are included as component units in MUSC's financial statements), including purview over the organizations as they relate to the total program of the Medical University. The Chief Executive Officers of the MUSC affiliates, except UMA and MUHA, report to the Vice President for Academic Affairs. The positions of Associate Provost for Education and Student Life, Associate Provost for Institutional Research and Assessment, and Associate Provost for Research report directly to the Vice President for Academic Affairs.

Scope and Content:

The Vice President for Academic Affairs Collection, 5 cubic feet, 1959-1999, documents the administrative activities of the office since its inception in 1966. The collection traces the development of various university programs and also the termination of programs; contains records concerning important academic issues pertaining to faculty and students such as tuition and fees, grievance procedures, and contracts, positions, and pay; and MUSC's collaborative programs with the Veterans Administration Hospital, University Medical Associates, and South Carolina academic institutions. The collection also includes files on the 1969 Hospital Workers Strike.

The types of records found in this collection include correspondence, memoranda, reports, minutes, policies and procedures, strategic plans, notes, speeches, journal articles, budget reports, studies, proposals, and news clippings. Records are arranged into three series: (1) Academic Affairs, (2) Administrative Files, and (3) Student Affairs.

Arrangement:

The collection was transferred to the University Archives with folders originally arranged alphabetically by folder title; also folder contents span the tenures of several Vice Presidents for Academic Affairs. During processing it was determined that the files should be rearranged according to series and sub-series identified in South Carolina's "General Records Retention Schedules for State Colleges and Universities." Files were ultimately arranged into series by function and there under arranged alphabetically by folder title. Contents of folders were maintained in their original order. Files are not arranged by terms of vice presidents.

<u>Series 1: Academic Affairs</u> – Correspondence, memoranda, reports, policies and procedures, financial statements, press releases, agendas, minutes, CVs, and news clippings pertaining to the administration of MUSC's academic functions and affairs. Records document the Vice President for Academic Affairs' overall management of issues relating to individual faculty, academic departments, programs, and positions. Includes files on the establishment and termination of academic positions and programs. The series is arranged alphabetically by folder title; 1.25 cubic feet; 1969-1999.

Series 2: Administrative Files – Correspondence, memoranda, policies and procedures, minutes, notes, reports, surveys, financial statements, contracts, articles, news clippings, and proposals documenting the overall administration of the office of the Vice President for Academic Affairs. Includes files on the 1969 Hospital Workers Strike; administrative positions and staffing; affiliations with other hospitals including the Veterans Administration, Roper Hospital, and St. Francis; university affiliations with other colleges and universities; committees pertaining to academic affairs; and tenure. The series is arranged alphabetically by folder title; 2.75 cubic feet; 1959-1999.

<u>Series 3: Student Affairs</u> – Correspondence, memoranda, policies and procedures, financial statements, reports, notes, and minutes pertaining to the administration of student affairs and activities. Records concern topics such as admissions, grievance procedures, student fees and tuition, student health, and the Wellness Center. The series is arranged alphabetically by folder title; 1 cubic foot; 1972-1995.
